## 1. Acceptance of Terms

---

By using the Lígalo En Línea platform (lialocontodo.com), the user fully accepts these Terms and Conditions.

- Upon registration and first login, explicit acceptance of the terms form is required.
- Continued use of the platform constitutes acceptance of any subsequent modifications.

## 2. Registration & Account

---

- Users must be 18 years or older to register.
- Only one account per person is permitted.
- Personal information provided must be accurate and truthful.
- The platform may request identity verification at any time.
- The user is responsible for maintaining the confidentiality of their credentials.

## 3. Deposits & Withdrawals

---

- Deposits are processed according to the methods available on the platform.
- Withdrawals are subject to processing times and verification.
- The platform sets minimum and maximum amounts for deposits and withdrawals.
- Administration reserves the right to request additional documentation for withdrawals.

## 4. Bets & Credits

---

- All bets are placed using account credits.
- USD is the internal base currency. Multiple currencies are accepted with automatic conversion.
- Bets are final once confirmed, except for cancellations per game-specific rules.
- Betting limits are set by administration and may vary by user.

## 5. User Conduct

---

The following is strictly prohibited:

- Fraud, collusion, or result manipulation.
- Use of multiple accounts (multi-accounting).
- Use of unauthorized automated software (bots).
- Harassment, abuse, spam, or discriminatory language in chat.
- Sharing login credentials with third parties.
- The platform reserves the right to suspend or close accounts that violate these rules.

## 6. Privacy & Data

---

- The platform collects data necessary for service operation.
- IP address tracking is used for fraud prevention.
- User data is not shared with third parties without consent.
- Sessions are managed securely with CSRF tokens and HttpOnly cookies.

## 7. Liability

---

- Users bet at their own risk.
- The platform is not responsible for connectivity issues on the user's end.
- In case of technical errors, the platform reserves the right to void affected bets.
- Results published by official sources are final.



## 8. Intellectual Property

---

- All platform content is the property of Lígalo Internacional.
- Reproduction, distribution, or modification without authorization is prohibited.
- Trademarks, logos, and designs are the exclusive property of their holders.

## 9. Modifications

---

- These terms may be updated at any time.
- Users will be notified of significant changes.

- The current version will always be available in the Regulations section.
